As a downstream user, we are in close contact with our suppliers and always obtain up-to-date information on the current SVHC substances.

We provide you with information on SVHC substances to the best of our knowledge and belief based on the information received from our suppliers.

On 04.02.2026 the ECHA SVHC candidate list was extended by 2 new substance. According to our suppliers, the newly added substance should not be present in our articles. If we become aware in individual cases that SVHC are used in articles, we will inform you.

According to our current knowledge and information from our suppliers, the following products contain more than 0.1 per cent by mass of the following substance, which is on the candidate list of substances of very high concern drawn up by the European Chemicals Agency ECHA in accordance with Article 59 (1) of Regulation (EC) No 1907/2006 (REACH):
